Explanatory Notes

The following notes are intended to provide further information on certain AGM agenda items.

Agenda item 5 – To change Rule 31 of the Society.

Currently Rule 31 of The Society reads: "The Society is to hold a general meeting (called the annual general meeting) within six months of the end of each financial year. The first annual general meeting may be called by the Society Board at any time within this period."

Historically the Society has always had difficultly in preparing its accounts in the six months for a November AGM. In recent years this has become more difficult as the Society's account cannot be signed-off until its subsidiary companies have been signed off. These subsidiary companies, that include the football club, have up to 10 months in law from the end of their financial year to sign-off their accounts. Further November contains very few fixed home matches, this is because the first and second FA Cup round ties typically fall in November. After careful consideration the Board have decided to recommend to the members that the rule be change to read:

"The Society is to hold a general meeting (called the annual general meeting) within eight months of the end of each financial year."

This provides the board with more flexibility to organise the AGM within its own rules.

As previously advised to members, there are two board vacancies due to be filled in this year's elections. As two nominations were received there is no need to hold a contested election among the membership as a whole.

However, in accordance with the Society's Election Rules (rule 8), an affirmative ballot is required at the AGM. Each of the candidates will be put before the meeting for the approval of members. To be elected to the society board each candidate will require the approval of at least half of the votes of those present or made by proxy.
